VIEW ON MARKET PERFORMANCE

Nifty fell for the fifth consecutive session, to close with the losses of 0.95% at 22488. From the recent high of 23110, Nifty has witnessed a fall of almost 700 points towards 22417. NSE cash market volumes increased 7% as compared to yesterday.

Nifty Midcap 100 and Smallcap 100 Indices underperformed the Nifty where they fell by 1.34% and 1.62% respectively. Declining shares outnumbered the advancing shares as advance decline ratio stood at 0.45 levels on BSE, lowest since 09-May 2024.

Amongst the sectoral Indices, Nifty Metal, IT and Pharma fell the most while Nifty Media and Bank ended in the green.

50 days EMA for Nifty is placed near 22380, which can offer support for the short term. Sustainable level below 22380 could drag Nifty towards the next support of 22054. On the higher side, 22700 could act as an immediate resistance.
