DAILY DERIVATIVE OVERVIEW



F&O HIGHLIGHTS

LONG BUILD UP IS SEEN IN THE NIFTY FUTURES

ACCUMULATE LONGS WITH SL OF 22700 LEVELS.

- Nifty ended higher on May 02 after a volatile session. At close, Nifty was up 0.19% or 43.4 points at 22648.2.
- > Long build up is seen in the Nifty Futures where Open Interest rose by 3% with Nifty rising by 0.19%.
- > Profit booking is seen in the Bank Nifty Futures where Open Interest fell by 3% with Bank Nifty falling by 0.34%.
- Nifty Open Interest Put Call ratio rose to 1.14 levels from 1.11 levels. Amongst the Nifty options (09-May Expiry), Call writing is seen at 23000 levels, Indicating Nifty is likely to find resistance in the vicinity of 22900 23000 levels. On the lower side, an immediate support is placed in the vicinity of 22600-22700 levels where we have seen Put writing.
- > Long build up is seen by FIIs' in the Index Futures segment where they net bought worth Rs 364 Cr with their Open Interest going up by 17491 contracts.


