VIEW ON MARKET PERFORMANCE

In a volatile session, Nifty ended lower on May 03 amid selling across sectors except metals. At close, Nifty was down 0.76% or 172.4 points at 22475.9. Cash market volumes on the NSE remained steady at Rs.1.26 lakh cr. Broad market indices fell less than the Nifty even as the advance decline ratio fell to 0.52:1.

Global equities were mostly higher on Friday ahead of key U.S. non-farm payroll numbers, helped by reassurance from the US Fed that the next move in rates would be down. Asian stocks surged to their highest in 15 months on Friday.

Nifty formed a bearish engulfing pattern on daily charts on May 03, engulfing the previous two candles. Nifty sold off after forming a new high in the morning and showed a feeble recovery late in the day. On weekly charts, Nifty ended 0.25% higher. It formed a bearish Gravestone Doji like pattern on weekly charts. Nifty could now head towards 22192 on the downside while 22619-22794 band could offer resistance on the upside.
