VIEW ON MARKET PERFORMANCE

Nifty continued to gain in the third consecutive session on May 14 after rising through the day with minimal corrections. At close, Nifty was up 0.51% or 113.8 points at 22217.9. Cash market volumes on the NSE were down about 7% to Rs.0.91 lakh cr. Broad market indices rose more than the Nifty even as the advance decline ratio rose to 3.24:1.

Global equities were mixed in muted trading Tuesday as investors waited for producer prices data for cues on inflation in the world's largest economy and ahead of Federal Reserve Chair Jerome Powell speech later in the day.

India's wholesale inflation climbed to the highest in 13 months, led by food and fuel. The Wholesale Price Index rose by 1.26% in April, as compared with 0.53% in March.

Nifty formed a bullish candle on May 14, but did not close at its intra day high. It can now rise towards the 22302-22348 band while 22131 could offer support in the near term.
