VIEW ON MARKET PERFORMANCE

Nifty struggled to find a direction on May 21 as India moves closer to the election results day. At close, Nifty was up 0.12% or 27.1 points at 22529.1. Cash market volumes on the NSE was up at Rs.1.32 lakh cr — highest since April 25, 2024. Smallcap index ended marginally in the negative even as the advance decline ratio fell to 0.66:1.

Global shares retreated Tuesday, even as U.S. Federal Reserve officials tempered investor enthusiasm about potential interest rate cuts as they called for policy caution and traders opted to take profits after being spooked by a surge in commodity prices.

The market capitalisation of companies listed on BSE has crossed a record \$5 trillion for the first time - hitting a fresh high on May 21. India became the fifth largest marketcap country after USA, China, Japan and Hong Kong.

Nifty formed a small positive candle on May 21. The sideways move continues, and Nifty could now face resistance in the 22578-22775 band while 22198 could offer support in the near term.
